**POSITION SUMMARY:** Healthcare Practitioners are Texas-licensed physicians or nurse practitioners who provide medical care and oversight to campers and staff at LLYC. This role provides medical evaluation and care for camper and staff illness and injuries that go beyond the Registered Nurses scope of practice.

**LLYC HEALTHCARE MISSION:** The Laity Lodge Youth Camp health services team is dedicated to promoting a healthy camp environment to minimize injury and illness of LLYC campers and staff to maximize their camping experience so that all may experience the love of Christ.

**ORGANIZATIONAL VALUES:** Rooted in our Christian faith, daily work reflects the Values of Hospitality, Stewardship, Unity, and Excellence.

**ESSENTIAL FUNCTIONS:**

- Serve as the leader of the healthcare professional team
- Evaluate and treat campers/staff referred by the camp nurses for injuries and illnesses after each meal and 24/7 for emergencies
  - Complete documentation on evaluated patients
  - Make referrals to outside medical care as needed
- Assume responsibility for medical emergencies at LLYC during time of service
- Wear radio or be available by phone 24/7 while scheduled at LLYC
  - Communicate whereabouts with Camp Nurses or Health Care Assistants
- Operate within the LLYC Healthcare guidelines and care protocols established by the medical director and the LLYC Medical Advisory board.
- Agree to follow the H. E. Butt Foundation Disaster Plan and work cooperatively with other parts of the Foundation regarding health and safety

**QUALIFICATIONS:**

- Medical Doctor or Advanced Practice Nurse Practitioner with current license to practice in the state of Texas
- Hold a current CPR/ACLS certification and a valid driver's license
- Preferably one-year clinical experience in acute care setting
  - Residency training is not included
- Must have up to date immunizations, including a current Hepatitis series
- Must agree to a criminal background check and complete the Sexual Abuse Awareness training per state camp regulations

**PHYSICAL REQUIREMENTS:**

- Ability to lift at least 25 pounds
- Able to walk on uneven ground and work in unpredictable outdoor environments
- Ability to respond to emergencies 24/7

**WORK ENVIRONMENT:**

- The Camp clinic is climate controlled. However, the Camp Healthcare Practitioner will go to various outdoor camp activities and settings during the day when needed.
- Ability to work outside on uneven terrain and in varying weather and environmental conditions
- Expect to routinely use standard office equipment such as computers, phones, radio.
